Local

·Upsilon Chapter Award, \$500, apply by March 31.

State

- ·Alpha Xi State Scholarship, up to \$1,000, one time only, active member at least 2 years, accepted and pursuing graduate work. Preference given to those who have shown leadership in DKG.
- ·Personal Growth Grants, for active members no longer teaching. One grant of \$200 awarded each year. Apply no later than March 26 to State Chairperson of the Committee.
- ·Elder Hostel Grant, up to \$500 for active members age 55 or older, must have been an active member for at least 5 years. Glenda Reynolds presented the original idea at a Spring 1992 Scholarship workshop in Casper. Dona Gates made the first contribution. Apply by July 30 for fall; Dec.30 for spring; March 30 for summer.

International

- •DKG Educational Foundation Cornetet Award, up to \$2000 one time award, non-degree, apply online by Feb. 1 for activity Mar. 15- Oct. 15, by May 1 for June 15- Feb. 15.
- International Scholarship, up to \$10,000 for doctoral studies, \$6000 for other graduate studies, must be a member for at least 3 years and accepted and enrolled in a graduate program, DKG Educational apply online by Feb. 1.
- ·Emergency Assistance Funds for those who have experienced catastrophic loss due to hurricane, tornado, flood or other natural disasters. Up to \$500.
- ·Golden Gift Leadership Management Seminar Award- for the development of the leadership, communication, and management skills of members. Apply no later than Dec. 1, 2013.
